


Private Equity 2-Day Bootcamp

In March 2025, we held a Private Equity Bootcamp at the historic Villa Bonn in Frankfurt - this year for the first time as a two-day event. Workshop leader **Steve Balaban**, **CFA** returned to deliver his highly rated Bootcamp, which combined well-grounded theoretical input with practical simulations.

Day one focused on key methods and techniques for deal evaluation, best practices in financial analysis and valuation, and a strong foundation in risk assessment and mitigation. Day two centered private equity due diligence, with highlights such as proven frameworks for value creation in portfolio companies, insights into operational and strategic improvements, and guidance on achieving high-impact outcomes.

We were especially pleased to welcome participants from multiple countries, making this a great international learning experience. Our sincere thanks go to all attendees for their active participation, and of course to Steve Balaban, CFA and Vuk Jevric for leading both days of hands-on learning.
