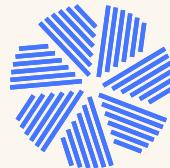
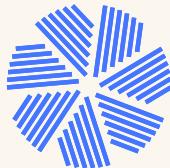
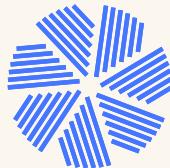
Event Highlights

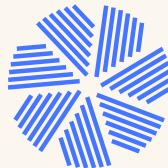

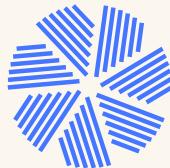
As a special highlight, we raffled three copies of his recently published book “The Psychology of Leadership” among our attending members.

Summer Happy Hour



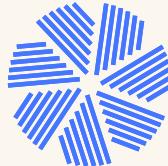
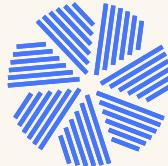
Our CFA Summer Happy Hour at Deloitte offered a relaxed setting for conversation and networking, bringing our community together in a vibrant summer atmosphere.

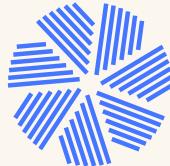

ESRS Simplification



Our expert working group "ESRS Simplification", led by **Danielle S. Budde, CFA**, with support from **Kirsten Baumbach, CFA**, **Christoph Klein, CFA**, and **Heinrich Ey, CFA**, conducted a member survey on the European Sustainability Reporting Standards (ESRS). The survey captures perspectives from financial professionals across various segments of the financial industry.

Published in November 2025, this paper provides insights into the current state of sustainability reporting and supports the ongoing ESRS simplification process led by EFRAG. It reflects CFA Society Germany's continued engagement in contributing practitioner perspectives to the regulatory development of sustainability reporting standards. For the paper, the working group surveyed members in Germany, and additional input was collected from members of CFA Society France and CFA Society Luxembourg. These results will be incorporated into a second part of the publication.

Spotlight on expert research



Amid ongoing discussions on pension reform in Germany, our pensions working group, led by **Peter Nies, CFA** and **Martin Herrmann, CFA**, is currently updating the *Position Paper on the Reform of State-Subsidized Old-Age Provision in Germany*. This update reflects recent developments and aims to provide a well-founded contribution to the current policy debate.

Dr. Gunther Hahn, CFA, supported by the capital market strategies working group, is preparing a new paper exploring how equities, contrarian behavior, and asymmetric decision rules can shape an effective asset allocation and bridge the gap between theory and practice.

Both papers are set for publication later in January – stay tuned!
