

# WHAT GOT US HERE WILL NOT GET US THERE: HOW THE EU AND GERMANY ARE PREPARING FINANCE FOR A NEW AGE.

On July 1st, Germany assumed the Presidency of the Council of the European Union with a clear mandate: Together for Europe's recovery. As the EU faces an unprecedented financial and economic crisis due to the global spread of Covid-19, the timing of the German Presidency comes at a crucial time when economies and markets need support and stimulation to overcome the challenges that lie ahead.

At our virtual conference "What got us here will not get us there" in cooperation with CFA Institute on September 29, we focused on the future of finance in Germany and the EU, but also on how Germany plans to support the recovery of the economy through new financial measures focusing on Green Finance and Digitalization.

Over 300 guests joined our virtual event that presented three top expert speakers. Dr. Jörg Kukies, State Secretary at the German Federal Ministry of Finance, and Dr. Sabine Mauderer, Executive Board Member of the German Bundesbank, both shed light on how Germany is addressing the current financial challenges and is promoting forward-loowking initiatives. While Thomas Wieser, Chair of the CMU High-Level Forum & former Secretary General of the Eurogroup, discussed the capital markets union from an EU perspective.

In the final panel discussion, the guest speakers gave more insights on the future of financial markets and answered questions handed in by the participants. The event was moderated by Susan Spinner, CEO at CFA Society Germany and Josina Kamerling, Head of EMEA Regulatory Outreach at CFA Institute.









# SUSTAINABLE FINANCE – MORE TO COME

On September 28, the next steps towards green recovery and social taxonomy were launched at the European Sustainable Finance Summit under the patronage of the Federal Ministry of Finance and the Federal Ministry for the Environment.

In our webinar, Wiebke Merbeth and Prof. Dr. Christian Klein highlighted the theoretical and practical considerations for the financial industry and the capital markets. The two experts offered the perfect mix of practice and science, as the lively panel discussion afterwards made clear. The topic remains exciting – we are looking forward to a follow-up.

# SUSTAINABLE INVESTMENT SOLUTIONS


