

MUNICH FORECAST DINNER 2022: THE CHINA FACTOR IN THE GLOBAL ECONOMY

Unfortunately, our traditional Munich Forecast Dinner could unfortunately not take place in the past two years due to the corona pandemic. Therefore, CFA Society Germany was all the more pleased to host the 13th edition of the event on 10 May 2022.

Over 70 professionals from the Munich investment community heard a fascinating keynote speech by renowned China expert Prof. Dr. Markus Taube on the competition on global leadership between China and the USA that will shape and significantly change the global economy for years to come. Clear is: Europe's businesses and politicians must react to this changing landscape and make fundamental decisions for their future.

But what is driving China's elites? How powerful and adaptable are China's companies and the economy as a whole? Are win-win solutions also possible with the "systemic rival" China? And what about Germany's thus far successful concept of "change through trade" in relation to China? These questions were the focus of Taube's keynote. Following his presentation, Taube answered questions from the audience, initiated inspiring discussions afterwards and helped to make the event a big success.




CALL FOR PAPERS | CFA GERMANY IN-VESTMENT RESEARCH AWARD 2022
