- You have signed the CFA Institute Code of Ethics and Standards of Professional Conduct

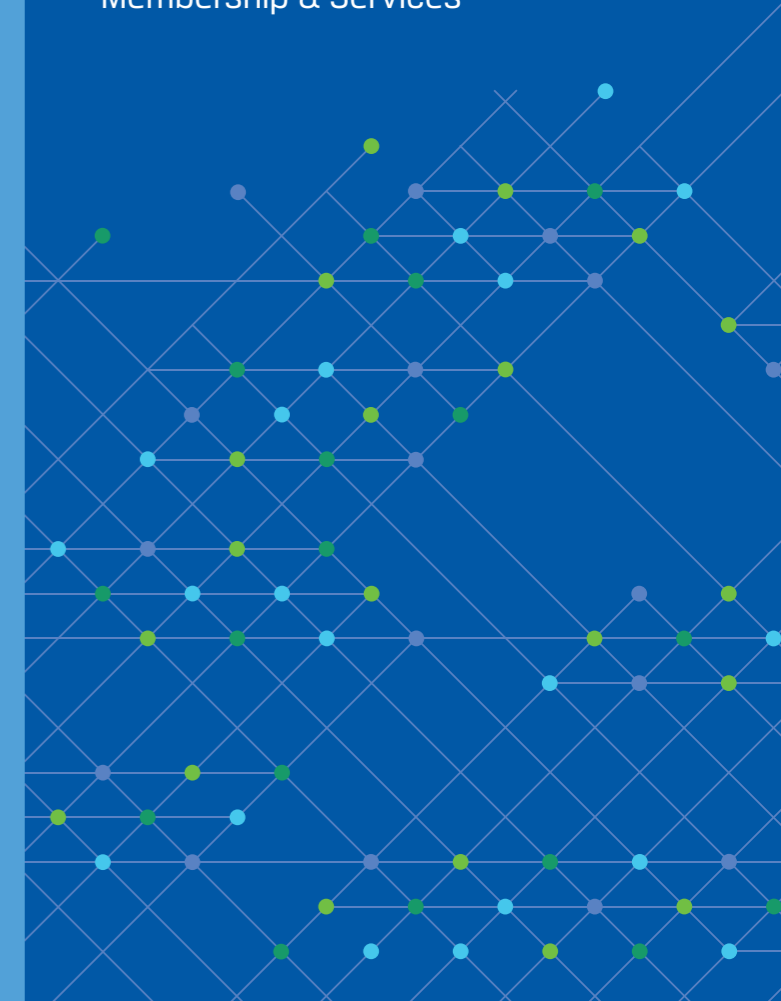
Candidate Membership costs EUR 75 per year. The membership year begins upon registration and membership is not automatically renewed.
